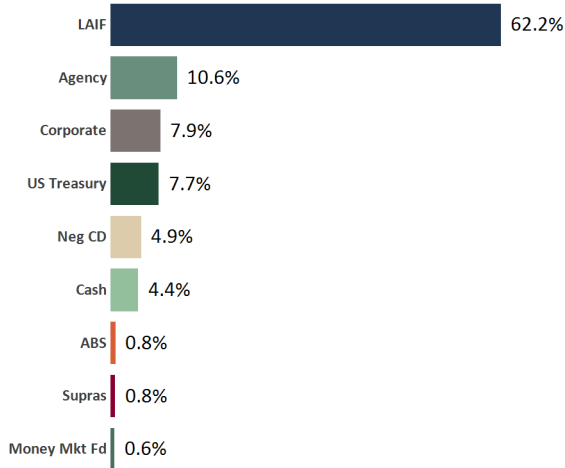

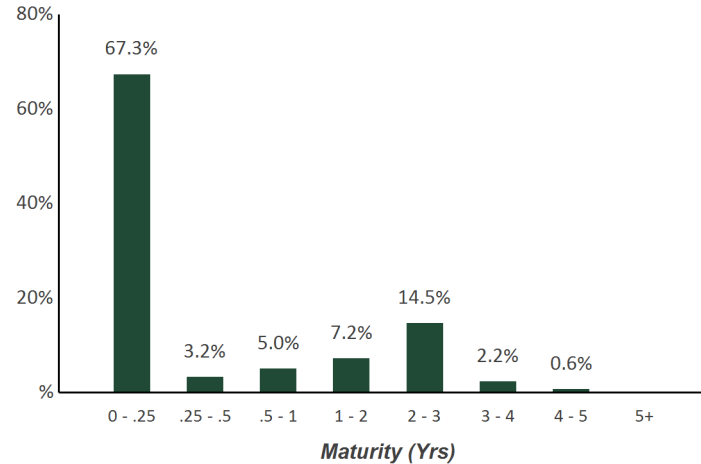

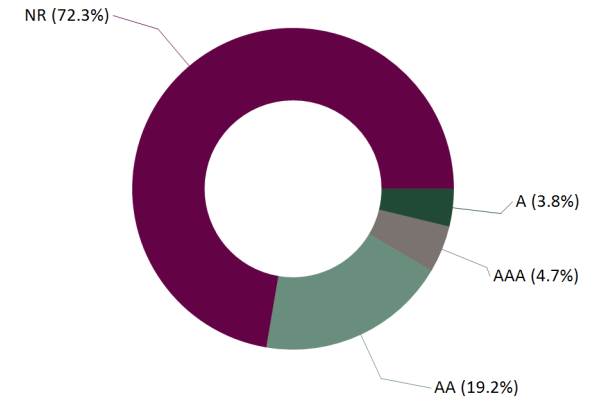
**SECTOR ALLOCATION**
