GENERAL CONDITIONS

1. A "property line" cleanout must be installed on every sewer lateral at a point designated by VSFCD.
2. All District sewer and cleanout construction shall be performed by a licensed Class A or C-42 Contractor.
3. VSFCD shall be notified 2 working days prior to backfilling of any sewer or cleanout construction.
4. Allowable connection to mains are:
 - a. Factory Wye for 6" or 8" or larger main.
 - b. Tap-Tite or equivalent may be used for 10" or larger main.
5. Connection permits will be issued upon payment of required fees and approval of required plans. If any.
6. Connection permits are void 12 months after issuance if construction has not begun.
7. Approval of lots for occupancy by VSFCD is conditioned upon connection to VSFCD approved facilities at the point of lot connection to a facility serving more than one lot. A condominium building will be treated as one lot. Approval for occupancy by the city or the county does not constitute approval for occupancy by VSFCD.
8. Repair to any sewer line requires a permit.
