**RESOLUTION OF RECOGNITION UPON RETIREMENT FOR  
ANDY JANNINGS, FIELD OPERATIONS SUPERINTENDENT**

**BE IT RESOLVED**, by the Board of Trustees of the Vallejo Sanitation and Flood Control District (District) of Solano County, California as follows:

**WHEREAS**, Andy Jannings began his employment with the District on April 29, 1990, as a Maintenance Worker Trainee, promoted to Maintenance Supervisor II in 1995, Field Operations Assistant Superintendent in 2003, and Field Operations Superintendent in 2007; and

**WHEREAS**, among Mr. Jannings' numerous accomplishments, he was instrumental in the planning process for application and winning the California Water Environmental Agency (CWEA) award for Collection System of the Year in 1995 and 1998; and

**WHEREAS**, Mr. Jannings was personally awarded the CWEA Collection System Person of the Year Award in 1995; and

**WHEREAS**, Mr. Jannings has been instrumental in the District's efforts to reduce inflow and infiltration **including** the use of pipe bursting, and working with the District Engineer to develop Capital Infrastructure Projects that reduce or eliminate sanitary sewer overflows throughout the system; and

**WHEREAS**, Mr. Jannings was the Collection System Committee Chairperson for the Redwood Empire Section of CWEA, and Mr. Jannings represented the District on the Solano Irrigation District (SID) Board; and

**WHEREAS**, Mr. Jannings has served the Community of Vallejo through earthquakes, storm events and sewer emergencies with unwavering dedication; and

**WHEREAS**, Mr. Jannings was a founding member of the Bay Area Clean Water Agencies (BACWA) and California Alliance for Sewer System Excellence (CASSE); and

**WHEREAS**, Andy Jannings retired on August 20, 2016; and

**WHEREAS**, upon his retirement as the Field Operations Superintendent, he will have 26 years of outstanding service to the District.

**IT IS, THEREFORE, RESOLVED**, that I, Osby Davis, President of the Board of Trustees; the Trustees of the Vallejo Sanitation and Flood Control District; Melissa Morton, District Manager; and the citizens of the City of Vallejo thank and express our appreciation to Andy Jannings for his 26 years of dedicated service.
